Highlights of "December 2004" figures

Assets under management by discretionary investment advisers (121 firms) totaled \pm 102,364 billion as of December 31, 2004, which showed an increase of \pm 9,203 billion (+9.9%) compared with March 31, 2004.

Discretionary assets under management was ¥75,640 billion, which showed an increase of ¥11,971 billion (+18.8%), while the number of the contracts increased to 6,999 by 670 (+10.6%) compared with March 31, 2004.

Discretionary assets under management by domestic and overseas pension funds showed an increase of ¥2,575 billion (+5.9%), while the number of the contracts decreased to 4,627 by 71 (1.5%) compared with March 31,2004.

Non-discretionary assets under management totaled \(\frac{\pmanagement}{26,724}\) billion with a decrease of \(\frac{\pmanagement}{2,768}\) billion (9.4%) compared with March 31,2004.
