■ Highlights of "June 2010"

The total assets under management by investment management member firms (232 firms) was Yen 152 trillion as of June 30, 2010, decreased by Yen 8,445 billion (-5.3%) from March 31, 2010.

The discretionary and the non-discretionary assets under management decreased by Yen 6,545 billion (-5.0%) and by Yen 1,894 billion (-6.7%) respectively.

The discretionary assets under management of domestic clients decreased by 5.3%, while that of overseas clients decreased by 1.5%.

The assets under management of wrap accounts was Yen 542 billion, showing a decrease of Yen 30 billion with an increase in the number of the contracts to 43,333 by 1,243 from March 31, 2010. The average amount per contract reported was Yen 12.5 million.

The statistics about real estate investment management member firms are as follows: the amount of the assets under management was Yen 3,604 billion with 450 contracts, while the amount of assets under advice was Yen 4,871 billion with 474 contracts.
