- ✓ The total amount of assets under management (AUM) of all member firms was Yen 633.4 trillion as of September 2024. It decreased by 18.5 trillion yen from June 2024.
- ✓ The amount of AUM of discretionary accounts (including accounts under advice) was Yen 587.8 trillion and it decreased by Yen 19.3 trillion from June 2024.

- ✓ The amount of AUM of real estate private funds, both discretionary investment management and investment advice, was Yen 24.6 trillion and it increased by Yen 646.4 billion from June 2024.
- ✓ The amount of AUM of wrap accounts was Yen 20.3 trillion and it increased by Yen 199.5 billion from June 2024. Number of contracts was 1,735,976 and it increased by 39,438.
- ✓ The amount of AUM of collective investment schemes (excluding mutual funds) was Yen 710.8 billion and it increased by Yen 16.0 billion from June 2024.
- ✓ The amount of AUM of total discretionary assets decreased by Yen 16.6 trillion, and total assets under advice decreased by Yen 1.9 trillion from June 2024.
